 - Became a hill supervisor in addition to assisting with patrol toboggan training.
- Attained my Professional Ski Patrol Association (PSPA) certification during the 1983-1984 season.
 - PSPA was established in 1954 as the Certification Authority for Professional Ski Patrollers
- Due to changing family dynamics and business commitments I had a lapse in my patrolling career and moved out west. On my family's return to NH I knew I wanted to get back to patrolling so my wife Marion and I enrolled in the OEC course at Ragged Mountain
- Elected to the Board of Directors (BOD) for the Ragged Mt. Patrol by the Patrol membership (approx. 60 patrollers), represented the members concerns and interest. When the ski resort was sold, the structure of Patrol management was changed and I was appointed Asst. Patrol Director for the next 8 seasons.
- Completed my Senior S&T classification and also recertified with PSPA in 2004

- Board of Directors (BOD) member of PSPA since 2006
